## SERVICE READY DATE THAT INITIATES SCHEDULING

**Service Ready Date** is determined when **ALL** the following requirements are completed:

- ◆ Final approved electronic site plan and your construction plans (in PDF format)
- ◆ Electric load data form submitted.
- ◆ Easements are notarized and received by OEC (when required).
- ◆ The electrical service route must be within 6" of final grade.
- ◆ A 10' wide service route cleared of debris and obstructions.
- ◆ The electric metering equipment must be installed and **State Inspected**.
- ◆ If a cement transformer pad was poured, must be cured for 10 days.
- ◆ Any private underground facilities **must be marked or exposed**.
- ◆ Any construction charges are paid in full.

**Construction Estimates** - Any construction price estimates given are based off historical averages and **WILL VARY** depending on site specific conditions and final design. An accurate invoice will be provided after an OEC team member conducts an on-site evaluation.

**Seasonal Installation (NON-REFUNDABLE)** – OEC's seasonal installation will be in effect November 1<sup>st</sup> thru April 15<sup>th</sup>. Installation during this time frame has additional costs due to poor weather or site conditions. This is a non-refundable cost.



1. Desired Meter Location
2. Water- Show current & proposed municipal water lines or private well. (Include connecting pipes to the building)
3. Sewer- Show current & proposed municipal sewer lines or private septic system. (Include connecting pipes to the building)
4. Propane (LP)- Show current & proposed tanks and connecting fuel lines.
5. Other above ground and underground facilities. **DIGGERS HOTLINE WILL NOT LOCATE THESE FACILITIES!**

  - ◆ Private underground wiring

I am the legal property owner and also agree that the area where poles or underground cable is to be installed will be within 6" of the final grade and will not be disturbed after the facilities are installed. It is further understood and agreed that no permanent facilities such as a porch, garage, sidewalk, swimming pool, patio, or similar structure, will be constructed over any underground cable or restricting access to the meter pedestal. Any costs of relocating the cable as a result of said construction will be paid by the property owner.
